Gentlemen:

We refer to your letter dated June 29, 2020 with regard to the postponement of Annual Stockholders' Meeting ("ASM") of Paxys, Inc. (the "Corporation").

According to your letter, the disclosure dated May 28, 2020 by the Corporation to the Exchange did not report the Corporation's Board approval of the postponement of ASM. Thus, pursuant to Sections 4.1, 4.4 and 7 of the PSE Disclosure Rules, you required us to explain in writing why the Corporation's delayed disclosure of the Board approval of the postponement of ASM does not constitute a violation of PSE Disclosure rules.

In this regard, we advise that there was no approval of postponement during the Board meeting on March 27, 2020. However, the Board authorized the President in the same meeting to approve the postponement of the 2020 Annual Stockholders' Meeting should prevailing circumstances necessitate it, and the new meeting date. The disclosure on May 28, 2020 indicated "March 27, 2020" as the date of Board approval since the authority relating to the postponement and resetting of the ASM was delegated to the President on such date. The postponement was not finalized sooner in case the new meeting date could already be announced simultaneously with that of the postponement.

In compliance with the Securities and Exchange Commission's Notice dated April 20, 2020, the Corporation published the notice of postponement for two (2) consecutive days with two (2) newspapers such as The Philippine Star and The Manila Times, in print and on-line format.
