Gentlemen:

We advise that Paxys, Inc. ("Paxys" or the "Company") held its 2017 Annual Stockholders' Meeting today, 6 December 2017, at 2:00pm at Manila Golf & Country Club, Harvard Road, Forbes Park, Makati City. The highlights of the meeting were as follows:

1. Annual Report for year-end 2016 and Update for the period ended September 30, 2017.

Year-end 2016 and 2017 Comparative Consolidated Results:

- Paxys has two remaining operating subsidiaries, namely, wholly-owned ScopeWorks Asia, Inc. (SWA) and 50%-owned Paxys Global Services (Dalian) Ltd. Both are generating profits to cover part of the overhead expenses of the Group.
- Y2016 Revenue is lower by 32% vs. Y2015 due to lower volume of business of SWA. This was offset by the decrease in the Cost of Service for the same reason. Y2016 General and Administrative Expenses are likewise lower by 3% due to cost efficiency. Y2016 Other Income is 49% higher vs. Y2015 due mainly to one-time reversal of long outstanding payables and increase in interest income. Overall, Y2016 resulted in a Net Income which is a turnaround from prior year Net Loss.
- Improvement in the USD/PHP exchange rate from Php47.06 at the end of 2015 to Php49.72 by end of 2016 resulted to translation gain amounting to Php136.9 Million on the Group's USD funds.

Financial Update for the nine-month period ended 30 September 2017 (unaudited):

- Net Income of P5.2M for the nine-month period ending September 30, 2017 compares favorably with that of the same period last year, taking out the one-off gain from reversal of long outstanding payables in 2016.
- Total Comprehensive Income is P69.7M. Of the P64.5M Other Comprehensive Income, P56.7M came from the Translation Gain on the Group's USD funds due to the appreciation of the USD against the PHP from year-end 2016 closing rate of P49.72 to September 30, 2017 closing rate of P50.82.



- 2. The Sixth Article of the Company's Articles of Incorporation, which currently provides for a total of nine (9) directors, was amended by decreasing the number of directors to seven (7).
- 3. The following were elected directors for the current term (2017-2018):
