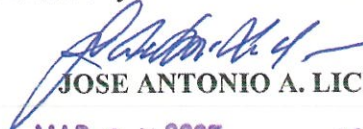
5. To the best of my knowledge, I am not the subject of any pending criminal or administrative investigation or proceeding.

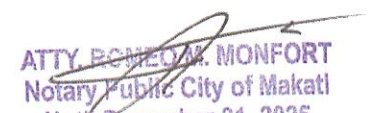
