#### Gentlemen:

We advise that Paxys, Inc. ("Paxys" or the "Company") held its 2022 Annual Stockholders' Meeting today, 13 December 2022, at 2:00 PM at Manila Golf & Country Club, Harvard Road, Forbes Park, Makati City. The highlights of the meeting were as follows:

- 1. Annual Report for year-end 2021
  - Revenues were mainly from the business of our operating subsidiary, Scopeworks.
  - The major component of revenues is data conversion, which decreased by 25% from P39.8M to P29.9M due mainly to technological advancement that has caused the continued reduction in the labor component required by Scopeworks' major client, and partly due to some operational shutdown in compliance to government-mandated lockdowns and community quarantine that the government extended in 2021.
  - The other part of the business, managed services, remains steady and continues to provide additional revenue stream for the Group.
  - Net result is an 18% decrease in total revenues for 2021.
  - Expenses in 2021 were lower by 16.7% compared to prior year. The reduction in expenses resulted from cost saving initiatives undertaken to mitigate the effect of decrease in revenues.
  - -This pertains mainly to the Interest Income from the Group's surplus funds. This is about 2.4% lower than other income in the previous year due to decrease in global interest rates.
  - Overall result is Net Loss of P13.4 million in 2021, a 48% improvement from the net loss of the previous year.
  - The Group's assets are mainly cash equivalents and investment securities. These funds are invested in short term placements and short duration bonds. About 62% of the funds are in USD denominated investment instruments.



- In 2021, Total Assets increased by about 1% accounted for mainly by the translation gain due to the USD appreciation from P48.02 as of year-end 2020 to P50.99 as of year-end 2021.
- -The Total Equity likewise increased by 3.6% from the previous year.
- The 3.6% increase in Total Equity is accounted for mainly by the said translation gain on the dollar funds of the Group, under Other Equity Reserves, which increased from 290M in 2020 to 430M in 2021.

Financial Update for the nine-month period ended 30 September 2022 (unaudited):

- Revenue from data conversion is lower by 67% for the first nine months of 2022 compared with the same period of the previous year due to the discontinuance of the data conversion operations of Scopeworks at the end of the first quarter of 2022.
- Revenues from Facilities Management and Other Services increased by 83% in 2022.
- Overall, revenue decreased by 11.7% in the first nine months of 2022 compared to the same period of last year.
- Expenses are 10% lower due to reduction in direct costs resulting from the discontinuance of Scopeworks operations.
- The group's income from surplus funds has started to recover. With improving interest rates, realized gains from fund redemptions, and favorable exchange rates, the group has registered about P64M other income as of the third quarter
- As a result, the unaudited Net Income for the nine-month period ending September 30, 2022 is about P22.9 million, an improvement from the P7.5 million net loss in the same period of last year.
- In summary, while revenues have gone down, the decrease in expenses and the significant increase
  in other income have resulted in net income of P22.9 million as of the end of the third quarter this
  year.
- Total equity increased by almost 10% from 3.76B in 2021 to 4.12B as of September 2022 accounted for mainly by the increase in net income and the translation gain on dollar funds of the Group due to the dollar appreciation from P50.99 at December 31, 2021 to P58.63 at September 30, 2022.
